Telecommunications Committee Meeting – December 5, 2016

Posted November 30, 2016 at 4 p.m. at the Town of Russell Garage, Town Clerk's Office and Town website. Notices sent via e-mail to the Ashland Daily Press and Bayfield County Journal.

The meeting was called to order by Committee Chairman Mark Bugher at 8:03 a.m. at the Town of Russell Garage. Roll call was taken as follows; present Supervisor Larry Meierotto and committee member Mike Cariveau. Clerk/Treasurer David L. Good was also present.

Theron Rutna representing the Red Cliff Band of Lake Superior Chippewa was also present.

The Pledge of Allegiance was recited by those present.

Approval of the agenda – A motion was made by Cariveau and seconded by Meierotto to approve the agenda. The motion carried.

PUBLIC INPUT – No members of the public were present and no public input was offered.

APPROVAL OF MINUTES – A motion was made by Meierotto and seconded by Cariveau to approve the minutes of the November 15, 2016 meeting. The motion carried.

OLD BUSINESS

Discussion Regarding Contact with Communications Companies Providing Telecommunications Services in the Town of Russell – A brief discussion was held. Bugher has reached out to Verizon and has had an initial contact. However, it was not the individual he needed to speak with. He is awaiting another response from them. Discussion was held regarding cellphone users in the Town. It was agreed that most residents have cellphones they use when away from their residence even if they do not have service at their residence. Cariveau felt data on potential numbers of cellphone users that come to the area for Apple Festival, Ice Caves, Dog Sled Races, Apostle Islands National Lakeshore, Red Cliff Pow Wow, etc. The value of this type of data was discussed. The value of these users needing to access data on their mobile devices was also discussed. The providing of data services by cellular providers may be of more interest to them than voice services. Bugher agreed to make contacts to collect visitor data. Cariveau felt we need to try and collect the data on a time of use basis, dates and months, etc. Meierotto also agreed that visitor data will be important since "new customer" potential will be minimal. Rutna felt we should discuss our interests with Norvado. They currently have fiber to the Bayfield Ferry Dock and serve Madeline Island. The Norvado fiber network was discussed. Rutna will contact information for Norvado. He also stated the Charter/Time Warner merger resulted in them creating a division that specifically deals with local and Federal governments and he will provide the committee with contact information for them also. survey in the mailing of the property tax bills, and/or an on-line survey on the Town's website. Possible questions for a survey were discussed.

NEW BUSINESS

Discussion regarding developing a "Vision Statement" – Bugher offered the following as a draft.

"To create an environment where residents of the Town of Russell have seamless, uninterrupted access to cellphone service and support policies that facilitate an infrastructure that allows for wireless internet service for home and business."

Discussion followed that the Town is not a provider of these services. Cariveau was concerned that a provider may want financial support from the Town. Bugher felt the Town is not financially able to do this. Good stated the Town could borrow money for this type of project providing it generated a cash flow to cover the debt service. Discussion followed that the Town could own telecommunications infrastructure but that it does not want to operate it. A provider could lease these facilities from the Town. Support for this would be up to the Town Board.

After much discussion and deliberation, a motion was made by Cariveau and seconded by Meierotto to adopt the following vision statement:

"To create an environment and partnerships where residents and visitors of the Town of Russell have seamless, uninterrupted access to voice, data and broadband service and where it is prudent financially and strategically relevant, support polices that facilitate an infrastructure that allows for voice, data and broadband services for home, business and government."

The motion carried.

Discussion regarding developing a "Strategic Plan" – Bugher suggested the following as key points of a strategic plan:

- 1. Convene a committee
- 2. Reach out to collaborators including the Tribe, NPS, etc.
- 3. Identify existing infrastructure needs of residents and visitors
- 4. Make contact with service providers
- 5. Access needs for infrastructure improvements
- 6. Enact policies to facilitate voice, broadband, data and wireless expansion
- 7. Identify costs associated with executing a plan
- 8. Execute the plan

Bugher agreed to refine the plan. It was suggested to add a timeline. Cariveau suggested a business aspect be included. Discussion followed. It was agreed that business is a consideration.

Discussion regarding identifying additional customers for telecommunications services and development of survey methodology regarding telecommunications customer needs – Bugher discussed the proposed survey. He indicated the Bayfield Chamber did a similar survey to what this committee is proposing. He requested a copy of the results from the Chamber survey. The survey will be mailed with property tax bills in December. Who will receive the survey and who will not receive the survey was discussed. The draft of the proposed survey was reviewed and changes recommended.

A motion was made by Meierotto and seconded by Cariveau to approve the survey above as revised. The motion carried.


Next Steps and Assignments – Nothing other than those items identified in the minutes. Good will provide preliminary survey results.

Governor Walker -- PSC Propose High Impact Broadband Investments

In mid-December a dozen town officials attended an exciting broadband announcement by Governor Walker. He is proposing to accelerate the investment in broadband infrastructure that will prove a crucial contribution to economic development and vitality across Wisconsin. The Governor's plan would increase funding for expanding broadband to underserved areas by

\$35.5 million. This year alone, funding for broadband expansion grants would increase from \$1.5 million to \$15.5 million. The Governor's proposal brings the total investment to enhance broadband to \$52 million.

On the same day, the Public Service Commission (PSC) announced it will increase funding up to \$26 million for rural energy programs that expand broadband.

These investments will have a substantial impact on towns and town residents throughout Wisconsin. Broadband is essential for competing in a 21st century economy and enhances businesses' opportunities to flourish in rural parts of the state. It allows students to do homework assignments at home, rather than traveling to Internet hot-spots miles away, and encourages tourists to stay longer.

In a press release lauding the proposal, I stated:

"In addition to jobs and quality of life, broadband is also critical for community development. When that home based business is in rural Wisconsin, the owner might teach CCD classes at church, volunteer as part of the Lioness Club, coach cheerleading at the school, or teach hunter safety classes. They are the fuel that propels a community to success, and they wouldn't be there without broadband. The combined proposals from the Governor and the PSC are a tremendous investment in that fuel".

Mark,

We do not have any study or research that shows actual numbers. These are out best guesses on how many people come here for tourism and events.

Apostle Islands National Lakeshore - estimates average around 200,000 per year for the last couple of years.

Bayfield County - estimate 1.5 million visitors into Bayfield County with 1 million of those to the Bayfield/Apostle Islands area.

Apostle Islands Sled Dog Race (Early February), 3 - 5,000 visitors Festival of Arts (mid July), 10,000 visitors Bayfield Apple Festival (Early October), 30 - 60,0000 Ice Caves - if they happen they can be huge, 138,000 people in 2014 over 10 weeks and 40,000 people in 2015 over just 9 days.

Populations: Bayfield - 500 year round and 5,000 summer Madeline Island - 250 year round and 3,000 summer

I can tell you that we get 400,000 visitors to our website every year, over 20,000 followers of our Facebook page, 2-300 people in our Visitor Center every day in the summer, and that room tax numbers have increased, on average, 3% per year for ten years.
