Project Location

- The proposed project involves improving the asphalt pavement along Old County K between WIS 13 and Little Sand Bay Road (approx. 3.3 miles).
- This segment of Old County K is located in the Town of Russell in northeastern Bayfield County.

Existing Facilities


- The existing roadway (Old County K) is a 2-lane rural highway which serves primarily to provide access from WIS 13 to the Town of Russell and Red Cliff Reservation, as well as tourist/recreational opportunities along the Apostle Islands National Lakeshore.
 - 2 10-ft. asphalt travel lanes; 3-ft. shoulders (1-ft. paved, 2-ft. gravel)
 - 66-ft. right of-way (33 ft. left and right of the centerline)
 - Posted speed limit of 45 mph
 - Land use in the vicinity of the roadway is primarily woodland and rural residential.

Project Purpose and Need

- The purpose of the proposed action is to maintain and improve an important roadway in the local transportation system by addressing pavement deficiencies along Old County K.
- The need of this project is to address the existing asphalt pavement showing signs of excessive cracking, potholes, and several portions of the roadway have already been patched.

Pavement Deficiencies

Proposed Improvements

- Remove and replace existing asphalt pavement within the project limits.
- If the project is awarded, construction is anticipated for summer of 2023.
- During construction, the project area would be closed to through traffic.
 Access would be maintained to properties along Old County K.
- No changes to speed limit are proposed.
- Asphalt travels lanes will remain 10-ft. wide; no changes to shoulders are proposed.
- No new right-of-way or other real estate acquisitions are proposed
 All proposed work would take place within the existing shoulder points of the roadway.

Costs

- If the project is chosen, funding will be provided by the Wisconsin Department of Transportation's (WisDOT) Bipartisan Infrastructure Law (BIL) Program.
- Federal funding will cover 80% of the anticipated construction and oversight costs, and the Town of Russell is funding the remaining 20%. The Town of Russell will be funding 100% of the design costs.
- The total cost for this project is anticipated to be approximately \$1,025,000; the final cost will be based on final quantities for the project.
