You are invited to attend a Public Involvement Meeting regarding the proposed improvements to Old County K between WIS 13 and Little Sand Bay Road in the Town of Russell in northeastern Bayfield County. An in-person meeting will be held at the Town of Russell Community Center located at 32500 W Old County K, Bayfield, WI 54814 on May 23rd, 2022 from 5:00-7:00 pm. Project representatives will be available at that time to discuss the proposed project and address any questions or concerns. Due to the COVID-19 pandemic, a Power Point presentation will also be made available to the public for viewing on the Town of Russell website from May 9th through May 23rd, 2022.


The proposed project scope includes the removal and replacement of the existing asphaltic pavement along Old County K between WIS 13 and Little Sand Bay Road. No right-of-way impacts are anticipated, and all proposed work would take place within the existing shoulder points of the roadway. If the project is chosen, construction is anticipated for the summer of 2023. During construction, lane closures would be utilized to facilitate traffic through the project area. Access will be maintained to properties along Old County K.
