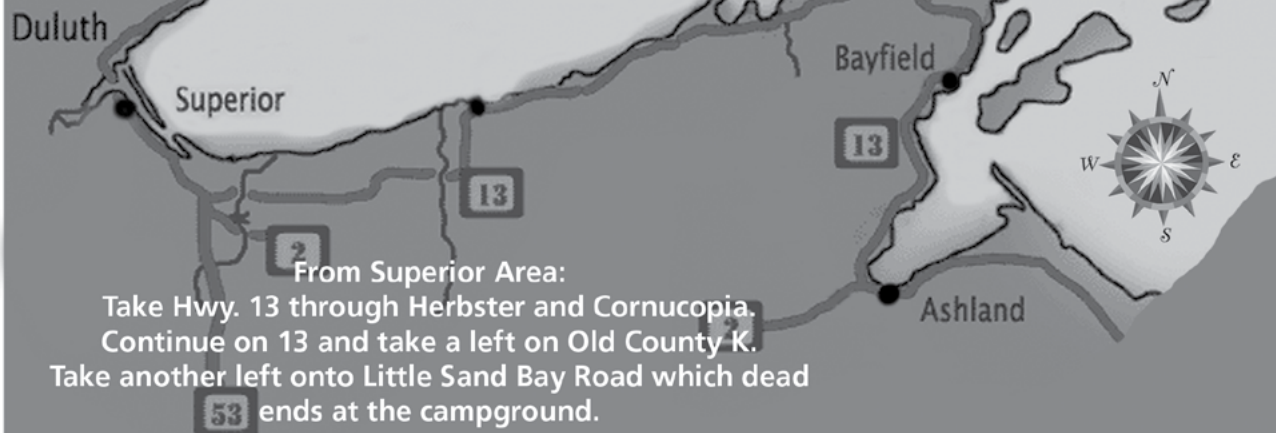


From Ashland Area:

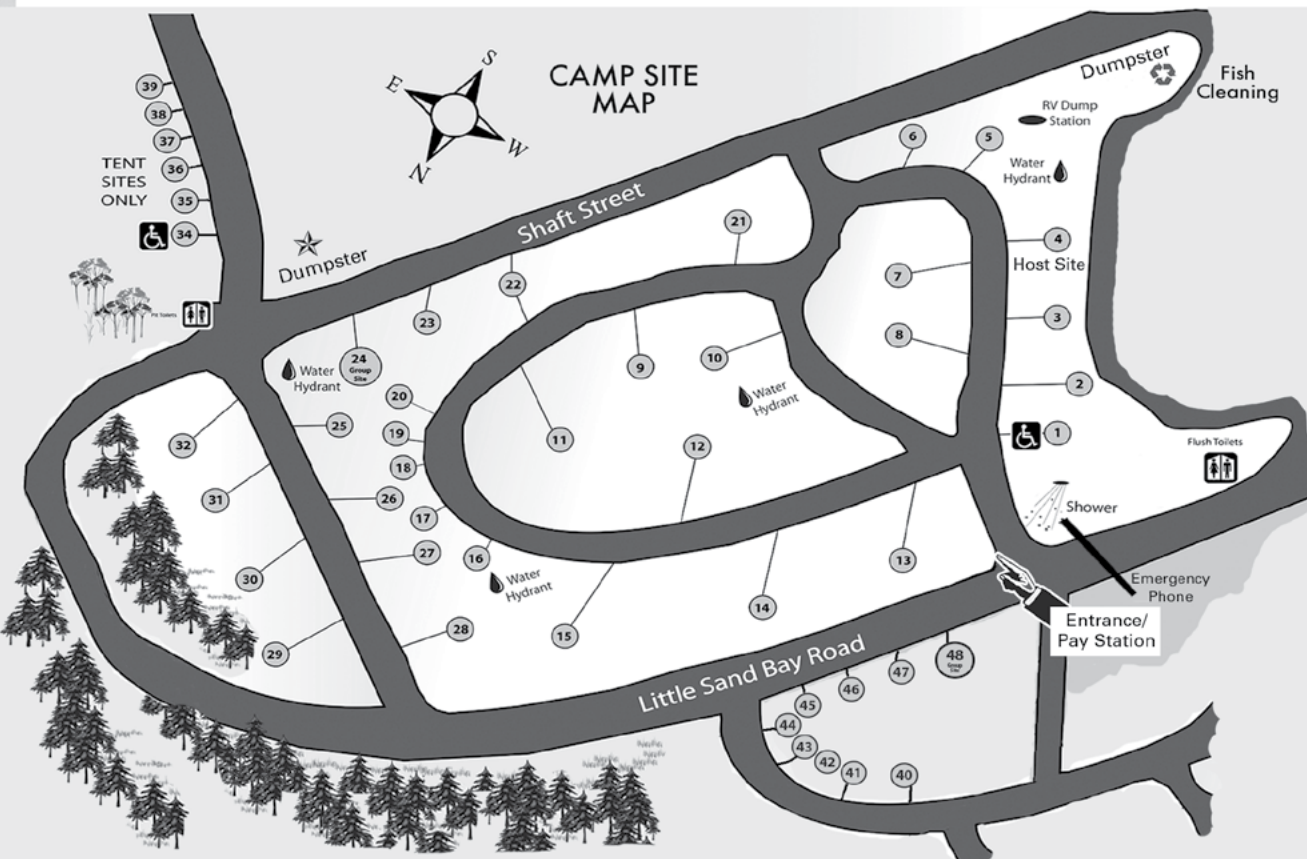

Please be aware that this Town owned and operated recreational facility is located within the boundaries of the Apostle Islands National Lakeshore (National Park) and you are also subject to the 9 Code of Federal Regulations governing visitors within the boundaries of the National Park. National Park Service Rangers may issue tickets for persons violating these Federal Regulations, If you want more information on this, please visit the Little Sand Bay Contact Station operated by the Park Service across the road from the campground.

CAMPING

RULES AND REGULATIONS

1. Quiet hours are 10:30 pm to 7:00 am daily.
2. Camping fees must be paid within 1 hour of occupying a site.
3. Users are prohibited from bringing firewood into the campground.
4. Dumping gray and/or black water on the ground from holding tanks is prohibited.
5. Fires may only be built in fire rings.
6. No more that 2 (two) vehicles may occupy a single campsite.
7. Electric pedestals are to be shared between two sites.
8. No burning of garbage is allowed. Dispose in dumpster.
9. Campsites are to be left clean at end of stay.
10. No tree and cutting of brush allowed.
11. No discharge of firearms, BB guns, or bows allowed in campsite area.
12. All animals must be leashed and under your control.
13. Horses are not allowed in the campground.
14. Maximum of 2 (two) tents per site.
15. One (1) RV or Travel Trailer per site plus one (1) tent allowed.



BOATING

RULES AND REGULATIONS

1. Use of the launch facilities and waterfront by commercial entities such as outfitters, charter operators, etc., is prohibited.
2. Non-motorized craft shall not be launched from the boat ramp, harbor beach, or swimming beach.
3. Vehicles and trailers must be parked in the designated parking lot and shall not be parked in the launch area or picnic area parking lot.
4. Launch fees must be paid prior to launching any craft.
5. Personal water craft (jet ski) use and launching is prohibited.
6. Unlawful to leave a vehicle unattended on the boat ramp and/or approach.
