

## **Camping Rules and Regulations**

- \* Quiet hours are 10:30 pm to 7:00 am daily \* Camping fees must be paid within 1 hour of occupying a site
- \* Users are prohibited from bringing firewood into the campground \* Dumping gray and/or black water on the ground from holding tanks is prohibited. \* Fires may only be built in fire rings. \* No more than 2 (two) vehicles may occupy a single campsite. \* Electric pedestals are to be shared between two sites.
- \* No burning of garbage is allowed. Dispose in dumpster. \* Campsites are to be left clean at end of stay.
- \* No tree and cutting of brush allowed. \* No discharge of firearms, BB guns or bows allowed in campsite area. \* All animals must be leashed and under you control. \* Horses are not allowed in the campground.
- \* Maximum of 2 (two) tents per site. \* One RV or Travel Trailer per site plus one tent allowed.

### **Boating Rules and Regulations**

\* Use of launch facilities and waterfront by commercial entities such as outfitters, charter operators, etc., is prohibited. \* Non-motorized craft shall not be launched from the boat ramp, harbor beach, or swimming beach. \* Vehicles and trailers must be parked in the designated parking lot and shall not be parked in the launch area or picnic area parking lot. \* Launch fees must be paid prior to launching any craft. \* Personal water craft (jet ski) use and launching is prohibited. \* Unlawful to leave a vehicle unattended on the boat ramp and/or approach.
